Inclusive and Equitable Climate Solutions: Prioritize the development and implementation of climate solutions that are inclusive, ensuring the active participation of marginalized communities, indigenous peoples, and civil society in decision-making processes, fostering equitable and just outcomes.

**Global Talent Mobilization for Climate Innovation**: Establish mechanisms to harness and mobilize global talent for climate innovation, encouraging collaboration among scientists, researchers, entrepreneurs, and professionals to drive sustainable solutions.

Circular Economy Initiatives: Promote and support circular economy initiatives, emphasizing resource efficiency, waste reduction, and sustainable consumption patterns to mitigate environmental impacts.
